Forest Area Schools Millage – Robert Morgan and Jill Smeyer discussed the improvements for the school, should the Bond Proposal pass.

Increase in burial fee – Upon research from the Cemetery Board they are recommending the Township raise the Full Burial Fee from \$575.00 up o \$650.00. Research found the cost for this process has increased for the Township. Forwerck made **Motion** to increase the full burial fee to \$650.00, Pearson Seconded, Roll Call Vote Finds; Pearson-Yes, Forwerck-Yes, Street=Yes, Zimmerman-Absent, Sorrow-Absent. 3-Yes, 2-Absent, **Motion Carried**.

Snow Plow Bids- No bids for snowplowing were received at this time. The ad in the Traverse City Record Eagle will be extended until November 15, 2018.
